### THE SCANDINAVIAN MIDSUMMER FESTIVAL is looking for High Quality Vendors for

June 21<sup>st</sup> and 22<sup>nd</sup>, 2025

at the Scandinavian Community Centre

6540 Thomas Street in Burnaby (Right by Hwy #1 between exits 32 & 33)

The Scandinavian Midsummer Festival, in its 28<sup>th</sup> year, attracts thousands of visitors. We are now looking for vendors who can offer us something special and exciting, be it traditional crafts with an innovative twist or something culturally relevant.

We offer you a table in one of our three categories at our festival for TWO days

**Event time:** Saturday June 21<sup>st</sup> 10:00 am - 11:00 pm. *Booths open until 6.00 pm*  
Sunday June 22<sup>nd</sup> 10:00 am – 4.00 pm

**Please make sure to choose the category that applies to you:**

**Crafters** (includes Artisans, Makers, Crafters and Artists) ..... \$175 including taxes

**Commercial Vendors** (with existing commercial space or an online store) ..... \$390 including taxes

**Service Organizations**

(includes not-for-profit, membership groups, rest homes and churches) ..... \$145 includes taxes

**Excluded:** *No Food Vendors accepted.*

**Tables specifications:**

- Tables are 8' long and will be outside on a grass field under cover in one of the five country tents.
- Rolling racks, extra tables or table extensions are **not allowed**.
- No Wi-Fi is available
- No driving on the field (grass area)
- **If power is required**, there is an additional charge; must be ordered at time of registration!
- Your table must be staffed and open during the festival event times indicated above; if you are a no-show at any time or you close early, you will not be eligible for a future Midsummer Festival.

**During the Festival there will be:**

- Continuous on-stage entertainment, Children's games, and an authentic Viking Village (the Vikings actually camp out all weekend!)
- The raising of and dancing around the traditional May Pole
- Cultural displays and Scandinavian food

## Scandinavian Community Centre Society Midsummer Market

### PARTICIPATION AGREEMENT 2025

BETWEEN

The Scandinavian Community Centre Society, hereinafter known as SCCS,

AND

\_\_\_\_\_, hereinafter known as The Vendor, in respect to the Scandinavian Midsummer Market to be held on June 21<sup>st</sup> and 22<sup>nd</sup>, 2025.

#### SCCS hereby agrees:

1. to provide previously reserved outdoor space at the Scandinavian Centre, in one of the five country tents;
2. to provide the number of tables as have been requested by the Vendor and agreed upon by SCCS on or before May 1<sup>st</sup>, 2024;
3. to advertise to the public at large, in the public media, i.e. radio and newspapers;
4. that all proceeds from the sale by the Vendor at the aforesaid market shall be retained by the Vendor;
5. that the SCCS reserves the right to limit items offered for sale and to verify conformance to the Participation Agreement. For all Crafters, Items offered for sale are to be produced by the Vendor.

#### The Vendor agrees:

1. to pay the SCCS in advance, on or before May 1<sup>st</sup>, 2025, the vendor fee for each table, requested by the Vendor under the provisions above;
2. to keep the booth open until 6 pm Saturday and 4 pm Sunday. Failure to do so will result in not being selected for the 2026 Midsummer Festival.
3. to pack up and remove from the premises at their expense, any belongings left over after the sale, between the hours of 16:00 and 18:00 on June 22<sup>nd</sup>, 2025;
4. to provide at their own expense personnel to assume responsibility for the goods, vendor's belongings, and everything brought to the location by the Vendor;
5. that the SCCS shall not be held liable for losses due to theft, breakage, fire, Acts of God, or any other causes neither during transportation to and from Market nor during the hours that the Market is in preparation or open to the public;
6. I have read, understood, and agree to comply with the Participation Agreement as set out by SCCS.
